
During the conversion, the date and time formats are now taken from the <u>WorkZone</u> <u>Configurator settings</u>. WorkZone Configurator administrators can assign specific date and time formats for each language. Note that this feature is only applied to date and time inserted during the conversion. Regular content in the documents is not affected.

WorkZone PDF 2020.0

 The <u>View errors and logs</u> section has been improved and now contains more detailed information.

WorkZone PDF 2019.3

By default, WorkZone PDF Crawler and its policies are now disabled after the installation. You can enable them in.



- WorkZone PDF Crawler logs have been introduced. To enable this functionality, the LogsLocation parameter must be enabled. See WorkZone PDF Crawler logs.
- Parameter ClearConfidentialInformation is renamed and its settings are extended. See <u>ActionsOnDocumentBeforeConversion</u> in WorkZone Installation Guide.

WorkZone PDF 2019.2

- You can now find information about installing WorkZone PDF in a common WorkZone Installation Guide that covers installation of all WorkZone products. See WorkZone Installation Guide.
- You must enable or disable the policies functionality in. By default, it is disabled.
- OData path has been removed from the web.config file.

WorkZone PDF 2019.1

 Two new parameters were introduced to deal with missing fonts during the document conversion to PDF or PDF/A:

- FaillfMissingFonts defines whether WorkZone PDF must check availability of missing fonts. By default, the parameter is disabled, that is the missing fonts are not checked. Note that WorkZone PDF checks missing fonts on the IIS server only for particular file types. See the list of file types in the Font check column in the Supported file types table.
- FallbackFont substitutes a missing font if FaillfMissingFonts parameter is enabled.

WorkZone PDF 2019.0

 In addition to converting different types of documents to PDF documents, the WorkZone PDF Engine service includes the API that extracts texts from various types of documents (including OCR).

WorkZone PDF 2018.2

- WorkZone PDF supports the functionality of previews of draft versions in. See more detailed information with examples in the API documentation.
- WorkZone PDF no longer installs Captia Web Client fixed lists.
- The time required for the PDF Engine to start up after being idle due to a time-out or when processing a request for the first time has been reduced. The default setting for the IIS has been changed from Terminate to Suspend, which means the process gets paged out to the disk instead of being terminated. Also, the PDF Engine application is now explicitly started by the IIS just after installation without having to wait for the first request. As a result, the time required to preview PDF documents in the WorkZone Client is also reduced.

The Application Initialization feature for the IIS 8.0 must be installed prior to installing WorkZone PDF Engine in order to take advantage.

WorkZone PDF 2018.1

New Case Notes report: A new standard report has been introduced enabling you
to create a report from the case notes and thereafter attach the report as a
PDF document to the case, thereby submitting any notes as attached documents to
the case. You can select which case notes are to be included in the case Notes
report.

- Deploy Custom Reports during installation or update: By placing your custom report templates in the Reports sub-folder of the same folder where the KMD WorkZone PDF.exe program is located, you can automatically deploy your custom reports during installation or update when selecting the mandatory Database Configuration option.
- Preview Text removed: The This is a Preview watermark text on documents viewed as PDF previews has been removed to facilitate reading of preview documents.
- Preview of original PDF Documents: If the original document attached to a case is in PDF format, either as an attached document or as a document directly saved as a PDF document, previews of that document will be taken from the original or saved PDF document instead of waiting for the WorkZone PDF Engine to create a PDF rendition of the original PDF document. The original PDF document will still be converted during normal operations.

WorkZone PDF 2018.0

- New standard meeting report: WorkZone Client now includes a standard meeting
 report with a cover page for the meeting, displaying the meeting details and meeting
 participants as well as displaying the meeting agenda. The meeting report itself contains the meeting agenda and all attached agenda documents.
- The DVS_RENDER_INFO table no longer contains the OK status in order to improve search performance when finding unconverted documents. All entries in the DVS_RENDER_INFO table with the OK status will be deleted upon installation and when updating to newer WorkZone PDF versions.
- The OutputPdfFormat parameter has been renamed: The OutputPdfFormat
 WorkZone PDF Engine custom and installation parameter has been renamed to OutputPdfArchiving and the values changes from Default/Archive to True/False where the False parameter value sets the PDF output format for generic usage and True sets the PDF output format for long-term storage.
- Improved Error logging messages: The error logging in the Windows Event Log has been improved to give a better overview of potential errors encountered during PDF conversions.
- The OutOfMemory error no longer stops the. The WorkZone PDF Crawler will restart 1 minute after an OutOfMemory error is logged. The document causing the error will be marked as Failed and the conversion process will continue.

- The procedure for updating previous versions of WorkZone PDF (before WorkZone 2018) has been changed. You must uninstall all previous versions of WorkZone PDF before installing any of the WorkZone PDF modules (WorkZone PDF Engine and/or WorkZone PDF Crawler). Remember to back up your WorkZone PDF Engine Web.config and WorkZone PDF Crawler application configuration files prior to uninstalling.
- All WorkZone PDF Engine and WorkZone PDF Crawler custom parameter settings have been moved to the WorkZone Configurator and the WorkZone PDF Crawler configuration file is now obsolete and will no longer be used. The WorkZone PDF Engine configuration file can still be used. As a result of this, you can now define parameters for each instance of the WorkZone PDF Engine and.
- Custom texts in headers and footers: When creating or editing custom reports or converting documents to PDF, you can add custom text to any header or footer placeholders, for example enabling you to create Page of XX footers where XX is the page number. The custom text will not be displayed if the header or footer placeholder does not contain data.
- Additional fields available for headers and footers: You can use field values from custom fields as well as standard fields from expanded tables in the report JSON in custom header or footer placeholders.
- The option to specify redirect options during the WorkZone PDF Engine installation procedure has been removed. You can still set up redirection rules for the WorkZone PDF Engine after the installation by using the standard Microsoft Internet Information Server redirection rules.
- The WorkZone PDF Crawler parameter IntervalBetweenIterations has been removed, optimizing performance and removing the need for a delay period between WorkZone PDF Crawler iterations.
- The WorkZone PDF Crawler parameter RecordsMaxLoads has been removed as the parameter no longer is relevant due to performance improvements and optimizations made to the.
- The WorkZone PDF Crawler now uses the WorkZone OData service to connect to.
 Connection parameters to the Workzone OData service must be specified in the Database Configuration installation option.
- Headers, footers, and table of contents are now automatically updated: The table of contents in Microsoft Word documents are automatically updated when creating

PDF documents. All document fields in the headers and footers are also automatically updated except the **Filename** field. The source word document is not updated.

- The installation procedure has been expanded and improved with the following changes:
 - The installation of WorkZone PDF Crawler now contains an embedded WorkZone PDF Engine, removing the need for the PDF Crawler to utilize a PDF Engine web service.
 - You can specify custom parameter values for WorkZone PDF Crawler and WorkZone PDF Engine during the installation procedure. Since custom parameter values are now stored in the database, this is done in the new Database Configuration installation option.
 - During the Database Configuration installation, you must specify connection parameters (user, password and location) for the WorkZone database and the WorkZone OData service.
 - You can specify standard (Real-time conversions) or customized (Custom)
 installation of the WorkZone PDF Engine during installation, defining only
 instance name in the standard installation.
 - The WorkZone PDF Crawler can only be installed in the standard version, but custom parameters can still be set in the database using the **Database** Configuration installation option or normal database operations (Create, Read, Update, Delete)
 - You can install WorkZone PDF Crawler up to 99 times per WorkZone server and can have up to 99 services running, each service handling one database.
- Reduced Backward compatibility: Note that WorkZone PDF 2018 only supports
 WorkZone products from 2017 and newer.

WorkZone PDF 2017 SP2

Microsoft Power BI: WorkZone PDF includes six Microsoft Power BI standard reports
which can assist you to quickly analyze progress and trends. The Power BI reports
require WorkZone Client 2017 SP1 as well as Microsoft Power BI July 2017 (version
2.48.4792.721) or newer. The new power BI reports are found in the Power BI sub-

menu in the Reports menu of the.

- Separate cover pages for PDF documents: Each document in a PDF document can
 be separated with its own cover page to better differentiate between the individual
 documents. The cover page can be configured for all reports (as a configuration parameter) or for the individual report (in the report request).
- Global page numbering for PDF documents: You can number all pages in a PDF document. Each page will receive its own page number corresponding to its placement in the PDF document. The optional page numbering of the original document is still retained. You can specify the syntax, location and alignment of the global page numbering.
- Page numbering removed from standard reports: All page numbering functionality
 has been removed from the standard report templates as page numbering now can
 be defined explicitly.
- Windows Server 2016 support: The WorkZone PDF Engine and WorkZone PDF Crawler applications can be installed and run on Windows Server 2016.
- Custom header and/or footer information: You can specify custom header and/or footer information in the report such as page number, page number total, document title and date. Microsoft Word field codes are used for the custom header and footers texts.
- New parameter BypassBoundaryCheckForFiles: You can specify a list of document types (by file extension) which the out-of-bounds check then will bypass when the PDF Engine or PDF Crawler converts documents to PDF. The out-of-bounds check will return an error if the document to be converted contains one or more objects which exceed the defined document boundaries.
- Preview Error messages: When a document could not be displayed in preview, the
 error message is simplified and short. A detailed error messages can be displayed
 by setting the **Debug** parameter to True in the Internet Information Server (IIS) settings. By default, this parameter is set to False.
- Improved error messages: Improved error messages. Error messages for unconverted files from the WorkZone PDF Engine and WorkZone PDF Crawler have been overhauled, reducing the amount of non-essential and potentially confusing information presented to the users.

Documents that are Locked (Document status: UL), Closed (Document status: AFS)
or Archived (Document status: ARK) and contain content that is out of bounds will
not be checked for out of bounds content when converted to PDF, even if the value
of the PDF Engine parameter FaillfOutOfBounds is set to True.

WorkZone PDF 2017 SP1

- The Unconverted list now only displays documents that have failed to convert with the REVIEW state. To display all documents that have failed conversion regardless of state (REVIEW, FAILED, and SKIPPED), use the All unconverted list. The All unconverted - total list is unchanged.
- A new Responsible OU field has been added to the Classification Scheme standard report and the FacetType column has been removed. The File_Class filter has been defined as the default sorting order of the report. When selecting rows in the report, the filter FacetPlan <> "J" is automatically applied.
- The EmailConvertWithAttachments custom parameter has been removed and replaced with the new ConvertWithAttachments parameter. The ConvertWithAttachments parameter defines whether or not document attachments are converted to PDF with the main document and can be applied to API calls, Web.config files or during installation.
- Microsoft Excel custom report templates: You can now create custom reports based on Excel templates. Like Word custom report templates, Excel custom report templates utilize Content Controls in the template to populate the report.

WorkZone PDF 2017

- You can now install WorkZone PDF Engine and WorkZone PDF Crawler using one installation wizard. See.
- The number of custom settings has been extended to include header, footer, and watermark. You can specify custom settings in the installation wizard, in the Web.config file, and as part of API requests.
- In policy based conversions, locked documents are not checked for out of bound content even if the FaillfOutOfBounds parameter is set to True.

- Documents that fail to convert to PDF because the file type is not supported now get the state SKIPPED in the **State** field in the DVS_RENDER_INFO table. See Conversion states.
- After upgrading WorkZone PDF Crawler now re-converts one previously failed document at a time and only when WorkZone PDF Crawler is idle. See Conversion states.
- You can now configure the maximum number of documents and policies that WorkZone PDF Crawler processes at a time using the two new WorkZone PDF Crawler configuration options RecordsMaxLoad and PoliciesMaxLoad.
- You can schedule when policy-based conversions are to take place, for example to avoid load on the server during work hours. See Schedule a policy.
- Two new WorkZone PDF Engine APIs are now available:
 - Create MSG files
 - · Convert MSG files to EML files and vice versa.
- API documentation is now part of the WorkZone PDF installation. After installation, you can enter http://<workzone URL>/Render/help in a browser to open the WorkZone PDF API documentation, for example http://db01/Render/help.

WorkZone PDF concepts

About WorkZone PDF

Products overview

WorkZone PDF is a WorkZone product that is used to convert existing documents to PDF. WorkZone PDF converts documents to either the default PDF format (PDF v1.7) or to the PDF/A format (PDF/A-3b). You can specify which PDF format to convert to during the WorkZone PDF installation. WorkZone PDF can be used as a standalone application or in combination with other WorkZone products.

WorkZone PDF consists of two modules:

- WorkZone PDF Engine A stateless Web Application that performs real-time conversions of files to PDF documents, that generates reports, conducts remerging, text extraction, etc.
- WorkZone PDF Crawler A Windows Service that is used for deferred, asynchronous conversions of selected documents, either manually or with policies.

If an organization uses WorkZone PDF with policies, WorkZone PDF Crawler searches for documents that have not been converted, and that match one of the defined policy. When a document that matches a policy is found, it is converted to PDF document and then saved in the WorkZone Content Server. See WorkZone PDF with policies.

Important:

A separate license is required to use the WorkZone PDF Crawler with policies.

WorkZone PDF usage by other products

WorkZone Content Server

WorkZone PDF Engine contains a.Net library that is used in a WorkZone environment for extracting texts from various types of documents (including OCR). The texts are then used for the WorkZone search functionality.

WorkZone Client

WorkZone PDF Engine is used to preview documents in WorkZone Client and WorkZone PDF Crawler is used to create high-quality PDF versions of documents. WorkZone Client also uses WorkZone PDF Engine to print case documents, reports, and case notes.

WorkZone Process

WorkZone Process uses WorkZone PDF Engine to print tasks and process history.

Smart Post uses the WorkZone PDF Engine to create the letters and remerge them.

WorkZone Mobile

WorkZone Mobile opens documents in PDF format created by the WorkZone PDF Crawler program.

WorkZone PDF Engine APIs

In addition to converting different types of documents to PDF documents, the WorkZone PDF Engine service includes the following APIs:

- Creates server-side emails (*.msg files) that can be streamed to clients. Users can then open the MSG files in Microsoft Outlook and add more information.
- Converts MSG files to EML files and vice versa.
- Extracts texts from various types of documents (including OCR).

Conversion process

About conversion

WorkZone PDF Engine converts one or more documents into a PDF document. A document must pass the following stages to be converted into a PDF document:

1. Getting the source file.

Files can be passed into the service in the following ways:

- Through URI (Uniform Resource Identifier) A URI to the file must be specified.
- By stream The file is provided directly to the service.
- Using JSON with a list of URIs to the files. Documents in the database can be referenced by providing a valid OData URI to the document.
- 2. Converting the file into a PDF document.
- 3. If Microsoft Office Word documents are converted, update the Table of Contents (TOC).

The table of contents in the source Word document will be automatically updated and used as the table of contents in the PDF document in order to ensure a correct TOC. The source Word document is not updated.

All document fields contained in the headers and footers are automatically updated. The **Filename** field will not be updated in order to maintain the source document filename.

4. Applying bookmarks.

In a merged document, a bookmark can be added for every source file. The bookmark name in the document is the link to the file.

5. Applying watermarks (optional).

A watermark is added to the pages of the converted PDF document.

6. Applying headers and footers (optional).

Headers and footers are added to the pages of the converted PDF document.

7. Merging.

Two or more documents will be merged into a single PDF document.

- 8. Applying optimization and compression.
- 9. Providing the PDF output file.

Conversion priorities

The WorkZone PDF Crawler constantly polls the documents database for documents to convert. Each iteration of the PDF Crawler service checks for any potential documents to convert and will thereafter convert these documents.

If there are no documents to be converted, the PDF Crawler service will wait for a number of seconds before starting a new search iteration.

The length of the wait period between PDF Crawler iterations depends on the origin of the document conversion. User requests and edited documents have a higher priority than documents that have failed previously and therefore the PDF Crawler iterations are shorter with regards to user-requested and changed documents.

The table below provides an overview of the priority of the conversion by request origin as well as how often the PDF Crawler starts its search for new documents to convert (the Iteration Start column).

The Priority column indicates which documents will be processed first by the PDF Crawler in an iteration if multiple documents are found.

Remerging documents

Configure WorkZone PDF

WorkZone PDF with policies

Prerequisite:

- A separate license is required to use the WorkZone PDF Crawler with policies.
- You must enable the policies functionality in WorkZone Configurator.

About policies

After installing WorkZone PDF Crawler, you can configure policies to define which documents are to be converted and in which priority.

You can specify which documents to convert based on the following criteria:

- Document state (for example, Draft, Locked, Archived)
- Document type (for example, Incoming, Outgoing)
- Document group (for example, Decision, Hearing, Complaint, Minutes)
- Case class
- · Date of last change

You create and maintain policies in the **dvs_policy** table that you access through the **ScanSQL** program, adjusting the policies to the requirements and work flow of your organization, for example, setting up Crawler policies to convert documents based on their date:

- Convert all documents for the last year
- Convert all older documents meaning documents older than one year.

You can also set up policies to convert documents based on:

- The on-going production of documents, for example the changed date >
 installation date so that users do not have to wait for the PDFs that they have requested.
- All archived documents (State=ARK | AFS) as a batch process for the purpose of delivery.

Policy priority

The highest priority is 0. You can assign as many priority values to the policies as you need, for example, 0, 1, 2,... 10, 11 and so on.

Setting policy priorities enables converting of important (high priority) policies first and relegates converting of less important (lower priority) policies later, when there may be vacant machine resources to convert documents of these policies - for example, certain document types (WorkZone Document types: DOK, EMBED, I and such) could be assigned a lower priority policy to ensure there are sufficient resources to convert more important documents from a higher prioritized policy.

Create a policy

To create a new policy, execute SQL similar to the following on the database that you want the policy to cover:

Example:

The policy converts all documents of the type DOKUMENT and with the document group REF that are not personal drafts and have been changed since May 4, 2017. insert into dvs_policy (policy_key, name, enabled, state, record_type, record_grp, cutoff_date, renderer, priority, case_class)

values(1, 'FixedPDFPolicy', 'J', 'UÅ|UL|ARK|AFS', 'DOKUMENT', 'REF', '>20170504', 'PDF', '0', ")

If the single quotes are empty ", there will be no restrictions as to which documents will be converted:

Example:

insert into dvs_policy (policy_key, name, enabled, state, record_type, record_grp, cutoff_date, renderer, priority, case_class)

values(1, 'FixedPDFPolicy', 'J', ", ", ", '>20110504', 'PDF', '0', ")

Example:

The policy results in rendition of all documents after a specific date, for example the last 3 years. For example, today's date is January 1, 2015 and the policy results in rendition of all documents 3 years back, that is January 1, 2012.

You can add several values for state, record_type, record_grp, and case_class fields using the "|" symbol, for example, "DO|I".

Error-checking

In the current version, there is no error-checking at the SQL level, which means that errors in, for example, the search criteria will only be revealed at run-time. Furthermore, there is no error checking on the stated requirements. For more information, see Troubleshooting policies and Troubleshooting and tips.

Change a policy

You can update a policy through SQL. For example, you can disable the 'FixedPDFPolicy' policy by executing the following SQL:

update dvs_policy set enabled='N' where name='FixedPDFPolicy'

Schedule a policy

You can schedule when to run policy-based conversions by adding weekday and time filters to a policy, see the days and hours in the Field descriptions. For example you may want to run policy-based conversions outside work hours to avoid extra load on the servers.

Create a policy that converts documents of the record type UÅ and the record group DOK. The policy runs on Saturdays and Sundays from 8:00 to 24:00.

Policy types

There are two types of policies:

Event-driven

Policies are aimed at the daily production requirements.

Batch-driven

Policies are aimed at catching up in the database where you want to impose new rules and produce new renditions. Batch-driven policies are also convenient when you want to start using WorkZone PDF in a running installation in the middle of a filing period and you want to prepare the existing document archive for transfer or distribution.

Event-driven policies

Event-driven policies convert all documents to PDF as they are produced to facilitate distribution.

Troubleshooting policies

The current version of WorkZone PDF does not have a user interface for entering and maintaining policies, and there is only little error handling when editing policies in SQL. Errors will be handled only at runtime, when the WorkZone PDF Crawler tries to fetch and interpret the policies.

There are two possible types of errors:

 One or more of the fields in a policy are not in a format which the WorkZone PDF Crawler can interpret.

If you write $M\&M^*$ as a criterion, it matches all documents with an M in the corresponding field because & is a SOM operator. This is probably not what you intended.

 The WorkZone PDF Crawler interprets the policy but not in the way you intended it to.

The last type of error is revealed only by the number of documents that are converted. You may experience that too few or too many documents are converted.



WorkZone PDF Engine scalability (HTTP load balancing using ARR)

You can configure Application Request Routing (ARR) to load balance HTTP requests to achieve high availability and scalability. This topic describes some of the features that Application Request Routing uses to monitor the health of the content servers and collect requests from a client to a content server.

About HTTP load balancing

The purpose is to load balance HTTP requests across several content servers using Application Request Routing as displayed below:



Each application server hosts WorkZone PDF Engine whereas ARR is a web farm controller.

Prerequisites

To configure the Application Request Routing module to load balance HTTP requests, the following requirements must be met.

- IIS 7.0 or newer, on Windows 2008 or newer.
- Microsoft Application Request Routing Version 1 and dependent modules.
- A minimum of two content servers with working sites and applications.

If the Application Request Routing module version 1 is not already installed, you must install it.

- Microsoft Application Request Routing Version 1 for IIS 7 (x86) click <u>here</u> to download.
- Microsoft Application Request Routing Version 1 for IIS 7 (x64) click <u>here</u> to download.

Follow the steps outlined in the <u>Install Application Request Routing</u> document to install Application Request Routing.

Another prerequisite is that the reader has defined and configured a server farm using the steps outlined in Define and Configure an Application Request Routing (ARR) Server Group.

Server Web Farms

Prerequisite:

You must install the Application Request Routing module before you can create a server web farm.

You can create and set up a server web farm in the Internet Information Services (IIS) Manager on the ARR machine, adding any required servers as necessary. You can add additional servers to the server farm later if the need arises.

Manage a Web Farm

Health check monitoring

You can configure health test monitoring in the Internet Information Services (IIS) Manager.

The Application Request Routing module monitors the health of the content servers in two ways:

- Via the live traffic
- Via an explicit URL testing

Live traffic testing

Live traffic testing is performed automatically by default when requests are made to Application Request Routing.

Explicit URL testing

The explicit URL testing is an additional test that you can use with the live traffic testing.

Tip:

- WorkZone PDF does not require caching by the Application Request Routing module and you can disable caching in the Internet Information Services (IIS) Manager.
- To avoid application server time-outs, it is recommended that you increase the time-out parameter value in the Internet Information Services (IIS) Manager.

View errors and logs

You can view WorkZone PDF errors in the following places:

- The DVS_RENDER_INFO table in WorkZone Content Server. It contains errors
 triggered by the document conversions. Users can view these errors in WorkZone Client. Administrators can view the errors in the ScanSQL program.
- The Event Viewer. It contains generic errors, warnings, or information regarding WorkZone PDF Engine and WorkZone PDF Crawler.
- The WorkZone PDF Crawler logs. Three logs were designed to track WorkZone PDF Crawler processes. Besides the errors, the logs also contain run-time type information.

Conversion errors

Conversion errors are stored in the **DVS_RENDER_INFO** table in WorkZone Content Server. Users can view these errors in WorkZone Client. Administrators can view the errors in the ScanSQL program.

View unconverted documents in WorkZone Client

The WorkZone PDF installation creates the following lists in WorkZone Client: **Unconverted**, **All unconverted** and **All unconverted - total**. Users can open these lists from the navigation pane on the Dashboard. The **Unconverted** list is displayed in the navigation pane by default. Users can add the other two lists as needed. See how to <u>add a list to the navigation pane</u> in WorkZone Client.

Prerequisite:

Users must have the LISTCONF access code.

• Unconverted (Danish: Ikke-konverterede)

The list displays changed by the current user documents that failed to convert due to some issues. The documents have the status REVIEW. It implies that the user can correct the issues and the documents will be converted later.

• All unconverted (Danish: Alle ikke-konverterede)

The list displays changed by the current user documents that cannot be converted. The documents have a status REVIEW, SKIPPED, or FAILED. In other words, the list contains documents that the user can correct and the documents that cannot be corrected.

All unconverted - total (Danish: Alle ikke-konverterede - total)

The list displays all documents that cannot be converted, even if the current user hasn't worked with them. The documents have a PDF status REVIEW, SKIPPED, or FAILED.

The lists contain the following PDF conversion specific fields:

- PDF status (Danish: PDF-tilstand) It can obtain three states REVIEW, SKIPPED, or FAILED - depending on the type of error. See <u>Conversion states</u>.
- PDF error message (Danish: PDF-fejlbeskrivelse) It shows a description of the error.

Handle conversion errors

All documents must be in a state where they can be converted or have a copy that can be converted. Depending on the state of the document and on the type of error, users can perform actions to correct the content and then have the document re-converted.

The way to correct documents that cause unsuccessful conversions depends on whether the document is a draft or not.

Drafts

If a document is in a draft state, for example, \mathtt{UP} or $\mathtt{U\mathring{A}}$, the user can correct the document, save it, and it will be re-converted.

Locked documents

If a document is locked and thus has one of the other states, for example, UL, ARK, AFS, and O, the user cannot change it and, therefore, it will never be converted successfully. Depending on the type of error, the user may need to create a new copy of the document, correct the errors, save the document, and it will then be converted.

Note: Even if the new version of the document is converted successfully, the old version will still be on your list of failed documents until your organization delivers documents to the Danish National Archives and starts a new filing period.



Event Viewer

You can view errors and warnings triggered by WorkZone PDF Engine and WorkZone PDF Crawler in the **Event Viewer** form under Windows logs. The **Event Viewer** form provides information on relevant User ID, Record ID, and error message.




The OutOfMemory exception

If an OutOfMemory exception is thrown, the event will be registered in the Windows event log and the WorkZone PDF Crawler will restart after 1 minute. The document that caused the OutOfMemory exception obtains status Retry and will be included later (around 1 hour) in the new pass of the WorkZone PDF Crawler.

Tip:

You can set the custom restart period in the **Restart service after** field on the **Recovery** tab of the KMDWorkZone PDF Crawler service properties. To open, click **Control Panel > Administrative tools > Services** form in the server.



Advanced logging in WorkZone PDF Engine and WorkZone PDF Crawler

To enable custom logging, you can use Serilog configuration. See Serilog documentation.

Auto-updated Word fields

When WorkZone PDF converts documents to PDF, it automatically triggers specific Word fields to update. This is to generate a PDF document that contains the most recent information. The Word fields are updated during the conversion in the whole document, including **Header** and **Footer**.

Important:

Word fields in the archived documents (ARK, UL, or AFS) are not updated during the conversion.

In the following table, you can see the list of Word fields that are updated during the conversion. For more detailed information on each of them, see List of field codes in Word.

Time for converting large documents is not sufficient

By default, ASP.NET grants 110 seconds to convert a document. However, in some cases, this time may not be sufficient. If this is the case, you can extend the timeout to any number you want. In this example, we'll show how to extend timeout to 600 seconds (10 minutes).

- Open Web.config file in the WorkZone PDF Engine directory. Its default location is the following: C:\Program Files
 (x86)\KMD\WorkZone\IIS\WorkZone\Render\Web.config.
- 2. Add the following parameter executionTimeout="600" to httpRuntime, for example:

Save the changes.

Error message "This access control list is not in canonical form and therefore cannot be modified"

If you see this message during the WorkZone PDF Engine installation, try one of the suggested solutions in articles: $\underline{1}$ and $\underline{2}$.

Invalid DSN during installation

If the installation fails with the message "DSN is invalid. Installation cannot be performed", you must ensure that the ODBC Data Source Name has the same name as the Transparent Network Substrate (TNS) Service name of the WorkZone Content Server Oracle database. For a solution to this problem, see The installation uses different names for DSN and TNS.

Note:

All ODBC DSN names are listed in the registry under: HKLM\SOFTWARE\
(Wow3264Node\)ODBC\ODBC.INI.

The installation uses different names for DSN and TNS

If your installation does not use the same name for ODBC (DSN name) and Oracle (TNS name) access to your database, you need to create a duplicate TNS name which is identical to the DNS name before running the WorkZone PDF Crawler installation. This extra TNS name is required only during installation, and can be removed after installation.

If your database uses the TNS name <TNS>, you can expose it as <DSN> from the database server by following the steps below:

- 1. On the WorkZone Content Server Agent Server, open the file <OracleHome>\Network\Admin\tnsnames.ora where <OracleHome> is the location where you have installed Oracle. You can use, for example, Notepad for editing this file.
- 2. Find the definition of the TNS name of your database:

<TNS> = (DESCRIPTION = (ADDRESS = (PROTOCOL = TCP)(HOST = scjor-a04.scanjour.dk)(PORT = 1521))

(CONNECT_DATA = (SERVER = DEDICATED)

Where <TNS> is the Oracle TNS name of your database.

- 3. Copy the lines above.
- 4. In the copy, change the Oracle TNS name to be the same as the DSN name you use with ODBC. The new entry will look like this:

Where <DSN> is the new name.

Do not change the old entry.

- 5. Save and exit thshames ora.
- 6. Verify that both TNS names work. Open a command prompt on the agent server and enter:

In both cases, the command should reply with a copy of the entry in tnsnames.ora followed by OK (20 msec) or similar.

The sent date and time in PDF version of an email may not reflect the time when the email was sent

This is due to the fact that the sent date and time of an email is the date and time of the Exchange Server time zone. So, if the sender of the email is in a different time zone than that of the Exchange Server, the sent date and time of the email is not the date and time where the sender sent the email. This is Outlook default behavior. The conversion of an email to a PDF document does not affect the date and time.

The format of the sent date in the PDF document is the default format, which is the format defined on the server. The timestamp format is UTC with time zone offset.

Note that UTC does not observe daylight saving time.

Documents with custom fonts do not convert correctly

When converting documents with custom fonts to PDF, the documents will be converted but they may not use the custom font and therefore not display correctly.

To make the documents convert correctly, install the custom font on the server where WorkZone PDF Engine is running.

Note:

After installing custom fonts on the server, recycle the PDF Engine App Pool.

Alternatively, set up the fallback font, which will be used instead of missing custom font.

The date is not displayed in the expected format

Dates are displayed in the format that is defined in WorkZone Configurator by default, unless you have defined another date format in the document. If the document does not display the expected date format, you can manually define the desired date format in the document, which will then be used instead of the standard date format from WorkZone Configurator.
